

The Recognition process detailed in EMAD R, Edition 2.0 has been followed and confidence has been gained that the **French State Aviation Safety Authority (DSAÉ)** regulatory approach can be recognised by the **Finnish Military Aviation Authority (FIMAA)**.

Notwithstanding the Accepted Recognition Delta listed in Table 1, the **French State Aviation Safety Authority (DSAÉ)** conduct of regulatory assurance, as detailed in their MARQ Responses to Sub-Sections A, B, C and D, is considered to be suitable for the recognition of authority as the competent Military Airworthiness Authority.

Accepted Recognition Delta	Justification
There is a delta between the DSAÉ's and the FIMAA's regulatory frameworks as Finland still mostly apply legacy regulation. This delta is acceptable as the scope of the recognition complies with Step 1 (General Recognition).	The DSAÉ regulatory framework is acceptable.

The Recognition Certificate will be reviewed for the first time on 1 January 2023 unless any significant changes (Step 18 of EMAD R refers) to the Authorities occur before that date.

Recognition Partners undertake to provide the following information relevant to the Recognition:

- a. Recognition Agreement between the **French State Aviation Safety Authority (DSAÉ)** and the **Finnish Military Aviation Authority**,
- b. Audit Report (incl. MARQ)

The essential principle that Recognition is a national responsibility is maintained; hence sovereign regulatory responsibility is not abdicated by issuance of this Recognition Certificate.
