- 1. Recognition, in this case, is of an Authority by another Authority. To achieve the goal of regulating once and using the outcome many times, the recognition process guidelines detailed in EMAD R have been followed and confidence has been gained that **LufABw**'s airworthiness assurance and regulatory approach is acceptable to **DSAÉ**.
- **2. LufABw**'s conduct of regulatory assurance is assessed as being at a standard by which the continuing airworthiness artefacts can be accepted by **DSAÉ** as described in The table here below.

Artefacts	Remarks
Approvals of maintenance and maintenance training organisations, issued by LufABw based on DEMAR 145 & 147 can be accepted by the recognising authority. Airworthiness Review Certificates issued by LufABw based on DEMAR M can be accepted by the recognising authority	
Maintenance DEMAR 66 licences issued by LufABw based on DEMAR 66 can be accepted by the recognising authorithy Assessment of maintenance training, if issued and deemed equivalent to DEMAR by LufABw, can be accepted by the recognising authority	
Audits and surveillance for the approvals of maintenance and training organisations may be conducted jointly.	Development of the process for conducting joint audits and surveillance is required.

- 3. This Recognition Certificate is valid until July 2025.
- 4. This Recognition Certificate will be reviewed for the first time at least 6 months before the end date of its validity unless any significant changes (Step 18 of EMAD R refers) to the Authorities occurs before that date.
- 5. The LufABw undertakes to inform DSAÉ immediately of any significant changes (Step 18 of EMAD R refers).
- 6. If no objection from LufABw or the concerned organisation, **LufABw** undertakes to supply on request approval certificates, audit reports, supporting documents, findings and subsequent closure action to **DSAÉ** for all initial approvals and on-going surveillance activity for approvals, accepted/to be accepted by **DSAÉ**.
- 7. All issued documents are remaining for official use only and may not be transferred to any third party unless written consent of the originator has been granted, Data protection regulation shall be considered,
- 8. The **LufABw** undertakes to inform **DSAÉ** in a timely manner of any concerns they may have relating to the performance of a maintenance or training organization, the approvals of which has been adopted by **DSAÉ** (as communicated to LufABw).
- 9. DSAÉ may, if the organisation concerned does not object and feasible for LufABw, join audits as observers.
- 10. The essential principle that recognition is a national responsibility is maintained, hence sovereign regulatory responsibility is not abdicated by issuance of this certificate.
- 11. The Recognition Partners' signatories below are duly authorised to make the agreements given above and do so in light of the EDA Steering Board decision dated 10 Nov 2008 in Ministerial formation.
